Mrs. Bombard reported that preparation for state testing has started, after-school study sessions will begin in a couple of weeks; the Science and Discovery Center will be doing our winter session soon; three new Spanish speaking students started today and their first day was great. A big thank you Marie Chianese and Jackie Medovich for all the support they have given our teachers in preparing for our new students. Whiney Romero, Jessica Fitzgerald, Hannah Parshall, and the students in their classrooms have done an amazing getting their rooms ready, including labeling every part of the rooms with Spanish labels and creating picture cards with Spanish words on them. So proud of our students for showing so much kindness and support for our newest Tigers.

Mr. Wood reported that winter sports are going well, tonight is senior night for wrestling; Eric Gutierrez will be taking two teams to the Owego Nazarene Church next Friday for a Quiz Bowl competition; January Regents testing will be the 22nd through the 26th, there will be 12 students taking 7 different tests that will be facilitated by Mr. Meadows, Ms. Kolakowski, and Ms. Baron.

Mr. Roe reported that the high school gym railings have been installed; over the holiday break abatement was completed in the crawl space under the girl's side of the Middle School gym; also, over break a problem with the heating system was discovered and corrected before staff and students returned; the planning phase has started to use the excess funds from the turf project to upgrade the stadium lighting to LED.
