5. REPORTS/PRESENTATIONS

Mrs. Wood and Mr. Roe attended the legislative meeting on January 18th. Mrs. Wood shared that a large part of the meeting was spent setting the agenda for the Legislative Breakfast coming up on February 23rd, electric buses and competitive PreK grants will be important topics on the agenda; a new board member workshop will be held on Tuesday, February 6th on Budget Development.

The next Health Trust Consortium meeting date has been changed to March 1, 2024

The next Workers' Compensation Alliance meeting will be held on March 22, 2024

There was nothing to report for other board reports, events, or updates.

Mr. Cook reported that 5th and 8th graders completed a practice computer-based testing session yesterday, it went well and brought up a few questions on special education accommodations; the high school drama club performed a preview of the upcoming musical today; 20-week reports will go home next week; winter sports are underway, modified wrestling is at Newark Valley tonight.

Mrs. Camin was unable to attend the meeting.

Mrs. Bombard was unable to attend the meeting and provided a written report that was read by Mr. Roe. Mrs. Bombard's report stated that Alex MacDonald and the Drama Club performed a preview of the upcoming musical for the elementary student, our high school students are so talented and many students left excited to come and see the full performance this weekend; letters of interest for Pre-K in the 2024-25 school year will go home this Friday and advertisements will be published next week, we currently have 22 students eligible for the program; Melissa Garcia will be working with our new Spanish speaking students beginning on February 5th, she has a four year degree in Human Development and is a native of Mexico; midyear benchmarking is complete, students have shown immense growth thanks to the efforts of our teachers and their parents on attendance.

Mr. Wood reported that the Quiz Bowl competition that was scheduled for January 19th has been rescheduled to January 31st due to bad weather that forced several schools competing in the competition to close; Regents testing is underway with two more tests left to administer this week; the high school drama club will be performing The Addams Family: A New Musical Comedy, this Friday and Saturday in the middle school auditorium; after a wrestling tournament in Newark Valley, we received several compliments on how polite and well-mannered our athletes and students were .

Mr. Roe reported that we are in the process of hiring another school social worker whose salary and benefits for the next three years will be covered by the Office of Mental Health grant the district was previously awarded; a presentation of the State testing bar charts for staff will be given at the Friday, February 2nd Conference Day and for the board at the next meeting; there was a meeting this week with all of the contractors, engineers, and architect for the upcoming Phase II work happening this summer, roof work may begin by the weight room once the high school students start Regents testing, Middle School gym work may begin after the Memorial Day break; the High School gym will be painted this summer and the district is finalizing a plan to organize the banners; despite the tricky weather forecast, we got all students to and from school safely and completed a full day of instruction yesterday.
