Mr. Cook reported that state math testing is underway and will finish up tomorrow; the state science test will be given next week; teacher appreciation week is being celebrated all week and has included theme days and lots of special treats/food; end of the year plans are being made; there will be an Outdoor Fun Night next Friday.

Mrs. Camin reported that 7<sup>th</sup> and 8<sup>th</sup> grade meetings have concluded; CPSE meetings have begun; it is a busy time of the year, when there is not a meeting happening, time is spent planning the next meeting or finishing paperwork for the previous meeting.

Mrs. Bombard reported that state math testing started today and will finish up tomorrow; teacher appreciation week is in full swing and there is so much to celebrate; UPK screening has concluded, another screening session will be held in August for any students registering between now and then; Kindergarten screening begins next week; CPSE meetings are wrapping up; field trips have begun, UPK, K, and 1<sup>st</sup> grades will be going to a Rumble Ponies baseball game next Wednesday, 5/15 and 2<sup>nd</sup> and 3<sup>rd</sup> grades will be going on Wednesday, May 29<sup>th</sup>; PreK has been visiting the elementary school more frequently in preparation for Kindergarten next year; today is school nurse's day and we have the very best there is!

Mr. Wood reported that the induction ceremony for Tri-M Music Honor Society is happening right now; several students traveled to Johnson City to participate in NYSSMA; Spanish Club traveled to the State Theatre in Ithaca for a concert and had dinner at Old Mexico Restaurant & Cantina; on April 30<sup>th</sup> our Envirothon team competed at the Regional Convention where they took 1<sup>st</sup> place for Tioga County and 3<sup>rd</sup> place overall in the Southern Tier Region out of a total of 29 teams, Ms. Barnhart and Mr. Tate are busy preparing our team to compete at the State Competition in a few weeks; the Spring Showcase will be held on Wednesday, May 15<sup>th</sup>, our arts, music, and agriculture students have a great evening planned; the Art Club recently attended the Feats of Clay competition in Syracuse; all of our spring sports teams have achieved the Scholar Athlete Award.

Mr. Roe elaborated on Mr. Wood's report of the spring sports teams receiving the Scholar Athlete Award and announced that the district will be awarded the Scholar Athlete School of Distinction award based on all our fall, winter, and spring teams having 75% of the athletes on each team maintaining a 90 or better average during the season, this prestigious award is a tribute to the hard work of our athletes, coaches, and staff.
