Mrs. Root called the regular meeting to order at 6:03 pm.

5. REPORTS/PRESENTATIONS

There was nothing to report for Legislative, Health Trust Consortium, Workers' Compensation Alliance, other board reports, events, or updates.

Mr. Cook was at the Middle School Spring Concert and unable to attend the meeting.

Mrs. Camin reported that new teacher one-on-one reflection sessions are complete; summer professional development plans have been made for August to give teachers a break for the month of July.

Mrs. Bombard reported that all of the ducks have been adopted to good homes, a waiting list has already been started for next year's hatchlings; Mason Tate and Jessica Clark did a great job planning and organizing Planting Fest this year, a big thank you to Justin Williams for transporting all of the students to and from Planting Fest; PreK went to Iron Kettle on Monday; 2nd, 3rd, and 4th grades enjoyed the Science Show; PreK and 3rd grade had fun with a visit from Reptile Land, snakes were in the building; 2nd grade will be visiting Vestal Gymnastics; Kindergarten will be visiting the Ross Park Zoo; Field Days will be Wednesday, June 14th with Thursday, June 15th set as the rain date; preliminary data from the state tests is in and being reviewed; plans are being made to include typing.com as a daily part of 2nd – 4th grades to help prepare for computer based state testing; BenQ boards will be installed in classrooms over the summer, a training on using the boards is being coordinated with Nick Aiello; PreK graduation will be on Friday, 6/16, Kindergarten graduation will be on Tuesday, 6/20, and 4th grade graduation will be on Wednesday, 6/21, all will be held in the elementary gym at 9am.

Mr. Isaacs thanked the Board for the opportunity to be here to help support the district; he also reported that Planting Fest was a success, several high school students were part of the festivities; the US History Regents was given on June 1st; the end of the year is a busy time with Chromebook collection, Regents reviews; the senior picnic and walk will be on June 13th, the senior trip to Hershey Park is planned for June 15th, and senior awards night is scheduled for June 20th.

Mr. Roe thanked Mr. Issacs for filling the roll of Dean of Students this school year; no outside certified applicants applied for the special education vacancy in the high school, Amy Baron has agreed to shift to special education to cover the vacancy for the 23-24 school year; smoke from the Canadian wildfires is being monitored on a daily basis, students have been doing all activities inside since yesterday afternoon; CRRSA grant amendment 005 allows for some of the remaining funds to be used for COVID- related stipends; the HS library has been updated with 500+ new books from a wide variety of genres; the turf project is going well, a pocket of water under the track was discovered and will be taken care of; the Phase II project is out for bid now, most of the project will fall under cooperative purchasing; Phase II will include the Middle School entrance, HVAC, and roof, along with the High School gym entrance all being done this summer; the High School kitchen and Middle School gym will most likely be done next summer due to the long lead time for securing equipment; we are hopeful to still be able to replace the Middle School gym floor this summer even if the rest of the work in the gym cannot be done until next summer.
