Mrs. Bombard mentioned that they are working on class lists and the master schedule; class lists will go out the end of next week. Summer Enrichment ended last Friday with 11 students attending. Summer move-ins have been mostly Kindergarteners so far.

Mr. Cook reported that the credit recovery program wrapped up, 14 students were invited to participate, 12 attended. All 12 successfully completed the program. Fountas and Pinnell training has been on-going with more training scheduled for mid-August. An accelerated Science program is being implemented in the middle school and there are 13 students eligible to participate.

Mr. Jacob Roe stated that they are 99% done with scheduling and all that's left are AIS classes. He has been working with teachers to start a mentor program in the HS, many details are left to be worked out. Also working with teachers for ideas on how to help students be more organized during the school year. Letters will be generated and sent with student schedules regarding cell phones and backpacks in the classrooms.
