A RESOLUTION OF THE TIOGA CENTRAL SCHOOL DISTRICT, TIOGA COUNTY, NEW YORK AS TO SEQRA DETERMINATION.

BE IT RESOLVED by the Board of Education of the Tioga Central School District, Tioga County, as follows:

<u>Section 1.</u> It is hereby determined that the Board of Education adopting this resolution has declared itself to be the lead agency under the State

Environmental Quality Review Act ("SEQRA") and the regulations promulgated thereunder for purposes of determining the environmental impact of the project described in Section 3 hereof.

<u>Section 2.</u> It is hereby determined that the project described in Section 3 hereof is determined to be a Type II Action as which it is therefore hereby determined such project will not have any significant adverse impact upon the environment pursuant to 6 NYCRR Parts 617.5(c)(2) and 617.5(c)(8). A project scope of work description in support of SEQRA compliance has been prepared and is attached hereto and is to be available in the office of the School District Clerk for inspection during regular business hours.

<u>Section 3.</u> The project which is the subject of this resolution is described as follows:

The construction of additions to and reconstruction of various School District buildings and facilities, in and for the Tioga Central School District, Tioga County, New York, including original furnishings, equipment, machinery, apparatus, site improvements, and other improvements and costs incidental thereto, at a maximum estimated cost of \$7,550,000.

Section 4. This resolution shall take effect immediately.

BE IT RESOLVED, by the Board of Education of Tioga Central School District, Tioga County, New York, as follows:

<u>Section 1</u>. A Special District Meeting of the qualified voters of said School District shall be held in the gymnasium at the Tioga Center Middle School in Tioga Center, New York, in said School District, on the 21st day of February, 2017, at 11:00 A.M. Prevailing Time, for the purpose of voting by paper ballot upon the proposition hereinafter set forth. Polls for the purpose of voting will be kept open between the hours of 11:00 A.M. and 8:00 P.M. Prevailing Time. The proposition to be presented is hereinafter set forth in the Notice of said Meeting as described in <u>Exhibit A</u> attached hereto and hereby incorporated herein by reference.

<u>Section 2</u>. The School District Clerk is hereby authorized to amend and/or supplement said notice of the Special District Meeting from time to time as, in his or her discretion, such amendment may be required.

<u>Section 3</u>. The School District Clerk is hereby authorized and directed to cause notice to be given of said Special District Meeting in substantially the form set forth herein by publishing the same four times within the seven weeks next preceding such district meeting, the first publication to be at least forty-five days before said meeting, in the Morning Times and the Press & Sun Bulletin, the official newspapers having a general circulation in said School District, the first publication to be at least forty-five days before said meeting, and by giving such other notice as in his or her discretion may be deemed advisable.

<u>Section 4.</u> To the extent required by law, the Board of Education shall appoint election personnel to conduct said Special District Meeting pursuant to a separate resolution of this Board of Education.

Section 5. This resolution shall take effect immediately.

NOTICE OF SPECIAL DISTRICT MEETING AND ABSENTEE BALLOTS Tioga Central School District, Tioga County, New York The Board of Education of Tioga Central School District, Tioga County, New York, HEREBY GIVES NOTICE that a Special District Meeting of the qualified voters of said School District will be held in the gymnasium at the Tioga Center Middle School, in Tioga Center, New York, in said School District, on the 21st day of February, 2017, at 11:00 A.M., Prevailing Time, for the purpose of voting by paper ballot upon the proposition hereinafter set forth. Polls for the purpose of voting will be kept open between the hours of 11:00 A.M. and 8:00 P.M. Prevailing Time. The proposition to be presented is as follows:

CAPITAL PROGRAM PROPOSITION

Shall the following resolution be adopted, to-wit:

RESOLVED that the Board of Education of Tioga Central School District, Tioga County, New York, is hereby authorized to construct additions to and reconstruct various School District buildings and facilities, including original furnishings, equipment, machinery, apparatus, site improvements, and other improvements and costs incidental thereto, at a maximum estimated cost of \$7,550,000; and to expend \$400,000 from the Capital Reserve Fund of said School District to pay a portion of the cost thereof, and that the remaining \$7,150,000 of such sum, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments as provided by Section 416 of the Education Law; and, in anticipation of such tax, obligations of said School District shall be issued.

SEQRA Status: The capital project described in the proposition above has been determined to be a Type II Action under the regulations promulgated pursuant to the State Environmental Quality Review Act ("SEQRA") which as provided thereunder has been determined not to result in any significant adverse environmental impact. The final SEQRA compliance documentation is available for public inspection at the Office of the School District Clerk during regular business hours.

NOTICE IS ALSO HEREBY GIVEN that applications for absentee ballots may be applied for at the District Office of the School District Clerk commencing thirty (30) days prior to the date of the Special District Meeting. Any such application must be received by the District Clerk at least seven (7) days before the date of the aforesaid Special District Meeting if the ballot is to be mailed to the voter, or the day before such Special District Meeting, if the ballot is to be delivered personally to the voter. A list of all persons to whom absentee voter's ballots shall have been issued shall be available for public inspection in the office of the School District Clerk not less than five (5) days prior to the date of the Special District Meeting (excluding Saturdays and Sundays) during regular office hours until the date of the aforesaid Special District Meeting. In addition, such list shall also be posted conspicuously at the place(s) of voting during the hours of such Special District Meeting. Absentee ballots must be received by 5:00 p.m. on the date of the election in the Office of the School District Clerk.

Pursuant to the provisions of the Education Law, a district qualified voter is eligible to vote by absentee ballot under one of the following conditions:

1. Illness or physical disability,

2. Business responsibilities or studies which require travel outside of the county or city of residence on the day of the vote,

3. Vacation outside of the county or city of residence, or

4. Detention or confinement to jail after conviction for any offense other than a felony.

Qualified Voter: A qualified voter is one who is: (1) a citizen of the United States of America, (2) eighteen (18) years of age or older, and (3) a permanent resident within the School District for a period of thirty (30) days immediately preceding the Special District Meeting and not otherwise prohibited from voting (i.e., mentally incompetent or convicted felon). NOTICE IS HEREBY FURTHER GIVEN that in the event of a weather or other emergency which necessitates cancellation of the February 21, 2017 meeting, said Special District Meeting shall be held on February 24, 2017 at the aforesaid time and place.
